The indictments were announced Friday by Sharon J. Zealey, U.S. attorney for the Southern District of Ohio, in conjunction with George M. Rezny, chief of the IRS Criminal Investigation Division in Cincinnati.

Walker is charged with conspiracy, two counts of making and subscribing a false income tax return and seven counts of aiding in the preparation of fraudulent income tax returns.

Keyes is charged with conspira-

false income tax return and one count of failure to file an income tax return. During 1994, the indictment alleges Keyes received \$274,095.47 in gross income, but allegedly did not file an income tax return.

Filing a false income tax return is punishable by up to three years imprisonment and a fine of \$250,000. Failure to file an income tax return has a maximum penalty of one year imprisonment and a fine of up to \$100,000.

"As the tax filing deadline approaches, taxpayers should be

good to be true and go beyond what the law allows," Zealey said in her statement.

Zealey said the investigation was continuing.

"The clients of these preparers could face possible civil tax consequences as a result of fraudulent income tax returns being filed on their behalf," Zealey said.

Initial appearances before a U.S. magistrate judge will be scheduled at a later date, and the cases have been assigned to U.S. District Judge John D. Holschuh.

At the same time a semi-tractor trailer used to transport mobile homes for Doyle Trading Irishman, Inc., of Reynoldsburg, was driven by William J. Scholar, 47, of Grove City and heading east on Columbus-Lancaster Road.

The bus pulled out in front of the semi-tractor and Scholar hit the front of the bus, but then went off

the left hand side of the road, rolling over.

Scholar was transported by Greenfield Township EMS to Fairfield Medical Center and was then flown via MedFlight to Grant Medical Center in Columbus. A Grant spokeswoman stated Scholar was in the intensive car unit Friday night listed in serious condition.

Benson was transported by Bloom Township EMS to Fairfield Medical Center where she Lt. Doug Wortman confirmed the driver of the semi was out of the truck when the first fire units arrived.

"Our first concern was for the safety of the two driver's," Wortman said. "Then we made sure the vehicles were not going to catch fire and to keep the fuel from getting into the stream nearby."

Wortman said no fire resulted from the crash and the firefighters were abel to soak up the fuel spill before it entered the stream.

No one else was injured in the accident and it remains under investigation.
