Mercury spill closes Fisher Catholic High

Fisher Catholic High School was evacuated Tuesday after a mercury thermometer broke open in a home economics class.

Three students in the class were taken by ambulance to Fairfield Medical Center after eating doughnuts that may have contained small amounts of mercury, said Lt. Ed Breining of the Lancaster Fire Department.

The students were taken to the hospital only as a precaution, he said.

A hospital spokesman said the students' mercury exposure was very low. They were treated and released, but doctors want the students to submit urine samples at a later date so they can check mercury levels.

The hospital also wants the 17 other students in the class to submit urine samples as a precaution.

Todd Spencer, a chemistry teacher at Fisher Catholic, said students in the home economics class were making doughnuts.

He said "about a gram" of

He said "about a gram" of mercury spilled from the thermometer.

Spencer said mercury could be dangerous if exposed to skin or breathed in over prolonged periods of time.

The incident happened around 1:30 p.m. Tuesday. The Lancaster Fire Department responded to the call. The entire school was evacuated and students were dismissed early.

"It's just like a fire,"
Spencer said. "With a small
fire, you evacuate the whole
school."

Breining said the students were using the thermometer to measure the temperature of oil used to fry doughnut batter.

The students ate the doughnuts and only later discovered the thermometer was broken.

Breining said firefighters put the pan with the oil in a snowdrift to cool the oil. A cleanup contractor would stop by later in the day to clean the pan.

Students who had cars left for home while the rest waited outside the main doors for buses or someone to pick them up. They were let back in the school for a short time to gather their belongings.
